9	General description of security measures, where possible.	<p>The distribution list is a digital file saved in SharePoint with restricted access. It can only be accessed by the staff from the concerned department.</p> <p>ESMA's IT infrastructure is protected by physical and logical security measures: the servers are installed on a high-security data centre with restricted physical access to the machines. Network firewalls protect the logic perimeter of the ESMA IT infrastructure; and the main computer systems holding the data are security hardened.</p>
